



New Service Grants Available

Partnerships for Change Program participants are invited to apply for additional services under a new grant agreement. This offering applies only to local units of government that wish to continue inter-jurisdictional cooperation and coordination efforts to improve planning, community development, and service sharing. Under this program, **Partnerships for Change** will pay 30% of all personnel costs incurred by LIAA for services provided from July 2011 through June 2012.

We know that intergovernmental cooperation in planning and community development can increase efficiencies, reduce redundancies and provide more consistent protections for natural and cultural resources. As a participant in the **Partnerships for Change Program**, your community has demonstrated how cooperation works and how it succeeds. We want to help you carry on with your cooperative community development work. That's the purpose of this new **Service Grant** effort: to support continuing intergovernmental cooperative and coordination efforts. Why Seek a Partnerships for Change Service Grant?

- **New U.S. Census Data** will be released this spring, making it a perfect time to revisit and possibly **update master plans**, recreation plans, and other relevant documents.
- Over \$102 million was awarded by the Michigan Natural Resources Trust Fund to local units with **approved recreation plans**. Cooperative recreation planning and operation offers more bang for the buck and opens the door to Trust Fund money. LIAA has extensive experience and a record of success in **cooperative planning for shared recreation services**.
- This is **a very low-cost option for exploring cooperative development opportunities**. Your community may want to explore new ways of achieving important objectives for community development, including public participation in placemaking projects, corridor development plans or economic development options for your non-motorized trail system.
- LIAA has assisted dozens of communities in establishing joint municipal planning commissions, recreational authorities, and other intergovernmental entities. Here's a **very low-cost way of evaluating options for joint service agreements** and moving forward.

The overall mission of the program is to foster new and expanded cooperation between cities, townships and villages in developing local land use policies and programs that contribute to the preservation of cultural and natural resources and encourage urban redevelopment. The program has been funded by grants from the Americana, C.S. Mott, Frey, W.K. Kellogg, and Fremont Area Community Foundations, as well as the Department of Environmental Quality's Coastal Management Program, MML and MTA. **Partnerships for Change** has fostered new intergovernmental policy and program improvements in 35 geographically dispersed and economically diverse communities throughout Michigan, encompassing over 140 local governments and touching the lives of more than one million people living in the participating communities.
